- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will

permit the exercise of the comptroller function within the municipality.

- 1) John Kane 410 Lippincott Avenue Mr. Kane questioned the drainage issue on Grant Street. There was a substantial downpour and the parents and students became very wet. Administrator Jack stated that there is no Stormwater routing on Grant Street and the water is diverted to Park Avenue. The Township has applied for a Safe Routes to School Grant in the past in order to rectify this problem, but was denied. The Township will apply again for the grant in order to attempt to rectify the situation. Different solutions to the problem were reviewed.
- 2) Giles Nolan 807 Rancocas Avenue Mr. Nolan stated his concerns regarding the condition of Whomsley Field which included glass in the field, the finished concrete and asphalt, the fencing, the sloping of the ground for ponding. Administrator Jack stated that she along with the Public Works Supervisor will inspect the fields and note any problems or concerns that are viewed. There is a list that will be submitted to the Engineer for inspection. Final payment will not be paid until all the concerns are rectified. Mr. Nolan also stated that the trash receptacles do not drain water, and may be a mosquito hazard.
- 3) Gary Artes 503 Eighth Street Mr. Artes stated that he thought that the contractor would put new baseball dirt at the fields. The Contractor only dragged the filed. There is a pad of concrete with dirt in front of the dugouts.
- 4) Mr. Loughry 643 Bridgeboro Street Mr. Loughry said that the work that was done is shabby. Mr. Loughry stated that the work that was done was not done to specifications and questioned why the Fields cannot be enlarged to make it a major field. Administrator Jack stated that the reason that they cannot be enlarged is because it would encroach on the BEMS Landfill. Mr. Loughry stated that Field One is a complete mess.

Mayor Conard stated that he wants the Engineer to inspect the Field along with the Administrator and the Public Works Supervisor.

5) Richard Naylor – East Hancock Street – Mr. Naylor questioned if his curbing will be repaired this year. Administrator Jack answered in the affirmative. Mr. Naylor questioned how to remove a tree on the curb line. Administrator Jack stated that a letter must be submitted to the Committee and then the homeowner may remove the tree. Mr. Naylor questioned the Chief of Police if charges were filed against people that were arrested. Chief Eliason stated that he is not able to answer that question.

It is anticipated that the deliberations conducted in closed session may be disclosed to the public upon the determination of the Township Committee that the public interest will no longer be served by such confidentiality.
